



TIPS AND THINGS TO KEEP IN MIND-

- When you have a Beauty and Barber business, you usually are considered “SELF EMPLOYED” or depending on how you file your taxes, you are categorized as a SOLE PROPRIETOR. However, there are many ways to file your taxes. Always UTILIZE A PROFESSIONAL.
- Typically Some Food Establishments are given CASH, 1099 NEC and/or 1099K forms for their services/ credit card sales (respectively). These forms differ from a W-2 because they do not withhold any taxes such as Medicare, Social Security, Federal or State income.
- You must declare (submit/report) ALL INCOME you received from your business. DO NOT just report the form that was sent such as the (1099 NEC or 1099K). You need to report everything including cash payments from other apps such as Zelle, Cash APP, Venmo, Paypal, Chime etc. □ SINCE TAX LAWS AND TAXES ALWAYS CHANGE, IT IS IMPORTANT TO SPEAK WITH A TAX PREPARER/ TAX ACCOUNTANT REGARDING YOUR TAX SITUATION. EVERY SITUATION IS NOT THE SAME AND DOES NOT ALWAYS FOLLOW SAME METHODS.
